CALIFORNIA CUP AND BMC TROPHY INTER-CENTRE CHALLENGE MATCH Saturday 23rd June 2007

SUPPLEMENTARY REGULATIONS

- 1. The MG Car Club Ltd will organise a closed permit Autotest for road going cars on Saturday 23rd June 2006 at Silverstone race circuit.
- 2. The meeting will be held under the General Regulations of the Motor Sports Association Ltd. (incorporating the provisions of the International Sporting Code of the FIA), these Supplementary Regulations and any written instructions that the organisers may issue for the event.
- MSA Permit Number to be advised.
- 4. Tests: There will be a minimum of 3 tests and a minimum of 2 attempts at each of the tests. The worst score recorded for each test will not count towards the overall total. Details of the tests will be sent with the final instructions.
- 5. Competition Structure

5.1. Classes

Class A: Saloon cars as defined by the MSA Regulations provided that drop-head or convertible cars compete with the hood or roof erected

Class B: Any MG Saloon defined as S, V, W, Y, Z and Farina

Class C: Standard Production MG Midgets & AH Sprites

Class D: Standard Production MGA, B, C & V8

Class E: Vintage & MMM

Class F: T Types

Class G: MGF/TF

Class H. MG Production Cars fitted with a locked or LSD

Class I: MG ZR, MGZS, MG ZT models

Class J: MG ZR, ZS, ZT and ZT-T

Class K: MG SV

In the event of insufficient entries to a class or a car not complying with the spirit of the event the organisers reserve the right to amalgamate or change the class of vehicle. All vehicles must comply with the MSA Technical Regulations.

5.2. Team Entries

California Cup: Open to teams of 3 drivers of MG cars from any classes B-K.

BMC Trophy: Open to teams of 3 drivers from classes A–K provided that the cars were manufactured by MG, BMC or some pre-cursor to BMC

Register Trophy: Open to teams of 3 drivers from the Vintage, MMM & T Registers driving cars in Classes E and F.

MGB Register Trophy: Open to teams of 3 drivers from the MGB Register driving MGBs and MGB GTs driving cars in Class D.

Where a team is made in the name of a Centre, all members of the team must be from that Centre.

The California Cup, The BMC Trophy and Register Trophy will be awarded to the teams defined in paragraph 5.2 above with the lowest total score. The MGCC will retain all team trophies, with perpetual souvenir awards for the individual team members.

5.3. Individual Awards

MG Magnette Award: fastest competitor driving an MG.

Any Make Award: fastest competitor not driving an MG.

Ladies Award

Novice's Award: A novice is deemed to be a competitor who has never won an award in an event organised under an MSA Permit.

Gerald Palmer Trophy: fastest competitor driving a pre 1969 RWD MG Saloon.

MGF Trophy: fastest competitor driving an MGF/TF.

Kimber Trek Trophy: fastest South West Centre member driving an MG.

Class Awards: fastest competitor in Classes A - J. In addition first class awards will be presented to the next 10% in each class, subject to an entry of 10 in the class.

- 6. The event is open to fully elected members of the organising club, and is a round of the MGCC SW Drivers Championship.
- 7. No competitor will be allowed to start the event until his/her Club Membership Card has been inspected at signing on drivers will not be allowed to compete unless Membership Cars are shown.
- 8. Only one entry may be accepted from any one member. No competitor may compete in more than one class. No car may be entered by more than two drivers. No car except when driven by two family members sharing the same membership number may be entered in more than one team or team award.
- 9. The maximum entry for the meeting is 70 the minimum is 25. Should the minimum entry not be reached the organisers reserve the right to either cancel the meeting or amalgamate the classes as necessary. Entry fees will be refunded in accordance with MSA Regulations. A number provided by the organisers will identify competitors.
- 10. Practising will not be allowed.
- 11. Any protest must be lodged in accordance with O.5 Protests.
- 12. The marshals will record the times and any penalties and be Judges of Fact.
- 13. The programme of the meeting will be: Scrutineering starting at 8.30am (individual times for scrutineering will be notified in the final instructions), any car not signed on by 9.15am will be excluded. First car starts at 9.30am.
- 14. Provisional results will be posted by 4.00pm on the Saturday in the main Club marquee.
- 15. The entry list opens on publication of these Supplementary Regulations and closes finally on Saturday 9th June 2007 (but may be extended at the organisers discretion). The entry fee is £10 for all classes. All entries must be on the official form and accompanied by the appropriate fee plus TWO A5 size SAE's for the final instructions and results. Entries to be sent to the Secretary of the Meeting. Please note the entry fee does not include entry to the circuit.
