

**MGCC ( SW )**  
**KIMBER PRODUCTION CAR TRIAL 2007**  
**SUPPLEMENTARY REGULATIONS**

1. The MGCC ( SW ) will organise a 'Clubsport' Production Car Trial on **Sunday 21st October 2007** at Pagans Hill Farm, Chew Stoke, Bristol, **Map Ref 172/558628**, courtesy of **Tony and Sally Baker**.
2. The meeting will be held under the General Regulations of The Motor Sports Association Ltd ( incorporating the provisions of the international Sporting Code of the FIA ), these Supplementary Regulations and any written instructions that the organising club may issue for the event.
3. MSA Permit No ( to be advised ) has been issued.
4. The event is open to fully elected members of the following:
  - a) **MG Car Club**
  - b) **Bristol Motor Club**
  - c) **Bristol Pegasus Motor Club**
  - d) **The Classic and Historic Motor Club**
  - e) **Woolbridge Motor Club**
5. All competitors and drivers **MUST PRODUCE**:
  1. A valid club membership card. (a competition licence is **NOT REQUIRED** for this event).
  2. A valid MOT Certificate for the competing vehicle.  
Failure to produce either of the above **WILL RESULT IN THE ENTRY BEING REJECTED**.
6. The event is a round of the **MGCC (SW) Drivers Championship**.
7. The programme of the meeting will be :
  - Scrutineering starts at 9.30am.
  - Drivers briefing 10.25am.
  - First car starts 10.30am.
  - Any competitor not signed on by 10.30am may be excluded.
8. Public roads will not be used to link sections. There will be at least **4** tests on private land. There will be a minimum of **3** attempts at each test. (The number of attempts at each test to count may be increased from the minimum number subject to conditions on the day, details to be given at the drivers briefing by the Clerk of Course). Tests will be laid out within walking distance of the signing-on area, and competitors may walk the course prior to commencement. The entry will be split into groups starting at different tests, details to be given at the drivers briefing.
9. The event will consist of classes as follows:
  1. Pre-1955 MGs. This class may be sub-divided at the discretion of the Secretary of the Meeting.
  2. MG Midget and MG F.
  3. MGB, MGC, MGB V8.
  4. Front wheel drive four seat MG saloons and similar other makes.
  5. Other production sports cars.
  6. Front engine rear wheel drive production saloon cars.
  7. Rear engine production cars.
  8. a) Production Cars: Clan, Dellow, Daverian ,Denzel, Frazer Nash, Ginetta, Lotus 7, Panther Lima, Dutton Phaeton  
b) Other production cars manufactured on a limited basis and approved and listed by the MSA.  
c) Cars fitted with torque biasing different as catalogued for that car.  
d) Production cars not already listed in this class modified beyond the limits specified in M7 7.3: 7.4: 7.5: 7.6: 7.7 and 7.8 up to a limit as specified in M6.  
**The above classes may be sub-divided or amalgamated subject to entries.**  
**Entries of vehicles with four wheel drive or of pick-up design will not be accepted.**  
All vehicles must comply with MSA Technical Regulations and must be equipped with an effective silencer.

10. Awards will be presented at the MGCC SW Centre Annual Dinner (2008) as follows:
1. The best **MG Car Club** member driving an MG, irrespective of class (to be decided on index)
  2. The best **Bristol MC** member irrespective of class subject to **4** BMC entries O/A.
  3. The best **Bristol Pegasus MC** member irrespective of class subject to **4** BPMC entries O/A.
  4. The best **Classic and Historic MC** member irrespective of class subject to **4** CHMC entries O/A
  5. The best **Woolbridge MC** member irrespective of class subject to **4** WMC entries O/A
  6. **1st in class** subject to min **3** starters.
  7. **2nd in class** subject to min **6** starters.
  8. **3rd in class** subject to min **9** starters.
  9. **Novice** (as defined in E7 1.4)
  10. **Ladies** (subject to **3** entrants) Best performance irrespective of class  
**No competitor may win more than one award**
11. **The entry opens on publication of the S.R,s and finally closes at 9.30am on Sunday 21st October 2007.**  
The entry fee is **£10**. All entries must be made on the official entry form accompanied by the appropriate fee.

13. The maximum entry for the meeting, including reserves is **40**, the minimum is **15**.  
The maximum for each class is **20**, the minimum is **3**.
- Classes may be split if numbers are exceeded. Details to be announced before the start of the meeting.
- Should any of the above minimum figures not be reached the organisers have the right to either cancel the meeting or amalgamate classes as necessary. Entries will be selected and numbers issued in order of postal receipt and on the day in order of receipt. Entry fees may be refunded if an entry is withdrawn and notice given in writing to the Secretary of the Meeting at least 24 hours before the event is due to start.

15. Provisional results will be published as soon after the last competitor has completed the event and confirmed by despatching a copy in writing by post within 7 days of the event.
16. Any protest must be lodged in accordance with O.5.
17. Starting numbers will be notified to competitors at signing on. The starting signal will be under the control of the Starting Marshal at each test/section.
18. Competitors will be identified by **numbers** which **will be provided** by the organisers.
19. Marking and penalties will be as described in M3.4.10 to 3.4.17 where applicable.
20. All other General Regulations of the MSA apply as written.
21. **Entries will only be acknowledged if accompanied by a S.A.E.**
